**Outdoor Play Policy** 

Statement of intent

Ladybird Playgroup Thriplow CIO, believes opportunities for indoor and outdoor play are crucial to providing the Early Years Foundation Stage curriculum for children from birth to five years. Fresh air and exercise are important factors for promoting good physical health. Outdoor play will be encouraged in all weathers with the appropriate care taken to protect the children. Adults should be actively involved with the children in their

games and activities where appropriate, carry out written observations of children in deep meaningful play

and should not be solely in a supervisory role.

Aim

We endeavour to create an atmosphere where children can learn to take risks in a controlled environment.

The children have access to manufactured equipment alongside open-ended resources in order to develop

their imagination, solve problems and learn about the world around them.

The safety of the children accessing the outdoor area is crucial; a full risk assessment will be carried out and

reviewed regularly. Although the principles of continuous outdoor play will be adopted, the safety and well-

being of the children will always be prioritised and outside play may be temporarily restricted if this

compromises children's safety.

Procedure:

Prior to any child accessing the outdoors area a member of staff will complete a full daily risk

assessment of the area; ensure that all external gates are secured and check that all the equipment

is in a good state of repair removing any potential hazards where necessary.

The door to the outdoor area will be secured open when the children are in free flow to minimise any

accidents with children trying to open and close doors.

When children are independently free flowing from indoors to outdoors, health and safety must be

considered as a priority.

Children must be supervised at all times.

Should a child have an accident, a member of staff will take the child to the outer door and call for

assistance of the first aider present.

If the first aider on duty is outdoors, then a staff member from indoors will change places to allow the

first aider to deal with the accident.

Due to children independently accessing the outdoor space staff need to be vigilant to ensure the

children's whereabouts at all times.

At the end of the session or outdoor play staff must perform a head count against the register and

check all areas where the children may 'hide', before returning indoors and securing the door.

Our fire plan includes a safe collection point known to the children and the staff, by the table tennis
table, should a fire break out in the playgroup building whilst the children are playing outside. Further
details of the fire policy are set out in the Fire Safety and Emergency Evacuation Policy

A varied play experience will be provided outdoors as well as indoors.

• To enable children to fully experience outdoor play opportunities, parents are requested not to send their children to playgroup in expensive clothing, or crocs and open toed sandles, that could restrict play opportunities that children are able to participate in.

The following factors will be taken into consideration in different weather conditions:

## Hot Weather

- Children will be encouraged to play outdoors, however a risk assessment will be taken to determine if in the interest of children's safety outdoor play may be restricted at the hottest part of the day.
- Shade will be provided in the outdoor area.
- Children will be encouraged to drink water regularly
- Children will wear sun hats and sun cream will be applied before children play out in hot weather
- Parents are requested to ensure their own child has had sun cream applied in hot weather before they attend a session.
- The setting will provide sun cream for the parents to apply to their own child (if they have not remembered) or staff will apply suncream to the children no less than 30 minutes prior to going outdoors (a parent/carer consent form will need to be completed and signed prior to sun cream being applied).

### Wet Weather

- Parents are requested to ensure their own child dresses appropriately for the weather conditions.
- Some suitable waterproof clothing i.e. splashsuits and wellingtons are provided by the setting to
  enable the children to be able to experience splashing in puddles, playing in the rain or snow (if
  parents have these, then we ask them to please bring or let their child wear them as the setting does
  not have enough for every child)

### Cold Weather

- Children will be dressed appropriately with hats and gloves before playing outside.
- The playgroup setting has a small bank of 'spare' additional clothing that can be used in an emergency to ensure the children can continue to access the outdoor space.

#### **Staff Ratios**

• At all times staff: child ratios (both indoors and outdoors) will be maintained within Ofsted and the Early Years framework guidance. Should ratios change in the event of unforeseen incidents the
